After frog calls were recorded, we used Raven Pro Interactive Sound Analysis Software (CLO 2014) to edit the calls. The aim of call editing was to make a mp3 file with 10 minutes of calling which represented different call types. Using Ford (1989) definitions of call types; A) grunts and B) drone call types, we used the cut function ensured different call types were represented in a single recording. The final file had 10 minutes of consistent calling. This calling was repeated 5 times to form a 50-minute sound file. A 10 minute stretch of silence was then introduced after the 50 minutes of looped calling to prevent habituation to calling. A small mp3 player with an USB charging port and audio jack (female) input was loaded
